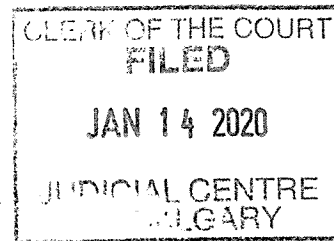

SUPPLEMENTAL AFFIDAVIT OF ROSS MARTIN


Affirmed on January 12, 2020

I, Ross Martin, of the Municipal District of Foothills, Alberta MAKE OATH AND SAY THAT:

1. I have personal knowledge of the matters and facts hereinafter deposed to by me, except where same are stated to be based upon information and belief, in which cases I believe them to be true.
2. I am an Applicant in this Application. I am a resident landowner in the Municipal District of Foothills ("Foothills") and have been since 1979. I am the owner and resident of SE 21-21-29 W4, the rural civic address for which is 276117 32 ST. E., Foothills.
3. Attached as **Exhibit "D"** to this Affidavit is a picture of a large roadside billboard sign and a map of its location. This sign contains the image of a unicorn on it and advertises show homes. It is located south of Calgary, within the northern border of Foothills, on the west side of McLeod Trail SE, shortly before it merges with Deerfoot Trail to form Highway 2 heading south. This sign is located a few kilometers up the highway from the trailer sign located on my property.
4. Attached as **Exhibit "E"** to this Affidavit is a picture of a second roadside sign located within Foothills and a map of its location. This "Malbec" sign is located on the east side of Highway 2, northeast of Okotoks.

5. Attached as **Exhibit "F"** to this Affidavit is a picture of a third roadside sign located within Foothills and a map of its location. This "New Holland" sign is located on the east side of Highway 2, east of High River.
6. Attached as **Exhibit "G"** to this Affidavit are two pictures of a long sign attached to a fence. The sign states, "I LOVE CANADIAN OIL & GAS / WE SHOULD BE PROUD/ TAKE ACTION/ BUILD THE PIPELINES/ WWW.CANADACTION.CA" (with the symbol of a heart in the place of "LOVE" and the symbol of a red maple leaf in place of "CANADIAN"). It is located on the east side of Highway 2A, south of Aldersyde.
7. I affirm this affidavit *bone fide*, for no improper purpose.
